





8. APPOINTMENT OF NON-PERMANENT TRUSTEES:

- That with a view to enable the Trustees to satisfactorily carry out (1) the intents and purposes of the Trust hereinbefore declared, the Board of the Trustees is hereby authorised and empowered to do acts, deeds, things which may be reasonable, proper and for the evident advantage of the Trust.
- The Trust may acquire by gifl, purchase, lease or otherwise (i) any property movable or immovable, and construct, after and maintain building or buildings which may be necessary or convenient fix the purpose of achieving the objectives of the Trust. To meet its objectives, it may also ruise louns from bunks or other financial

It may also mise funds through private or public donations, grants and financial assistance from State/Central Governments and other Institutions and placing suitable charges for the charitable services rendered which may be incidental to meeting the objectives of the Trust

Likewise, the Trust may transfer by way of sale, lease, gift, donation or otherwise any movable or immovable properties or other funds of the Trust to Government and other institutions/organizations, public or private bodies as well as individuals, not inconsistent with the objectives of the Trust. It may also extend financial aid or loans to deserving meritorious students for purpose of improving their education, so that they become valuable assets of the society.
